4. Details of our assessment

St Nicholas Crescent CSO, Pembroke, is permitted to only operate in rainfall or storm conditions. NRW received a self-report from DCWW and a crew attended. The discharge was stopped and the cause of it (blockage caused by build-up of silty debris in downstream sewer) removed. DCWW's ammonia readings in the lower millpond confirmed a low impact. The low impact and the self-report have been factors in issuing a warning for this incident.
