3. What will happen next?

Any non-compliance we have identified and recorded on this form is an offence. It can result in criminal prosecution or civil sanctions being imposed depending on the circumstances of the offence.

At this time, we do not intend to take any further action.

4. Details of our assessment

Due to the ongoing drought situation, an inspection of the licenced abstractions at Gwent Levels Wetlands Reserve was deemed necessary.

The inspection commenced at 10:00 on 28th August 2022 and was undertaken by NRW officers Emma Sharp and Simon Worrall.

There are two permitted water abstraction points; Point A at Monks' Ditch and Point B at

Chapel Reen.

Point A was visited first. The infrastructure was in place but there was no abstraction taking place at the time of the visit. The control cabinet was locked and therefore we couldn't access the infrastructure. There was water present in Monks Ditch (see photograph 1 below)

At Point B no abstraction was taking place and the pipework was disconnected at the time of the visit. See photograph 2 below which demonstrates this. There was water in Chapel Reen - see photograph 3 below.

On 1st September 2022 I received an email from Tom Dalrymple in response to a request for data returns. He confirmed that no abstractions had taken place in the last five years as the sluice has been removed downstream of the abstraction point and therefore the water level doesn't get high enough to abstract water. No data returns have been submitted since 31/03/2019.

Condition 8.1 (ii) of the permit states '*The Licence Holder shall send a copy of the record required by 8.1 (i) or summary data to the NRW on 31 March each year or within 28 days of being so requested in writing by the NRW.*'

As no data returns have been submitted for over two years, this is a breach of the permit condition stated above. I have scored this a CCS category 4, as there is no potential environmental impact. I have decided to issue advice and guidance in response to this permit breach and suggest that either data returns are submitted as stated in the permit, or the permit is surrendered as the abstraction is no longer in use.
