During the site inspection, it was noted that the borehole compound was very overgrown with brambles and was inaccessible, see below:



Condition 9 of your permit stipulates that daily readings of the meter must be taken:

9. RECORDS

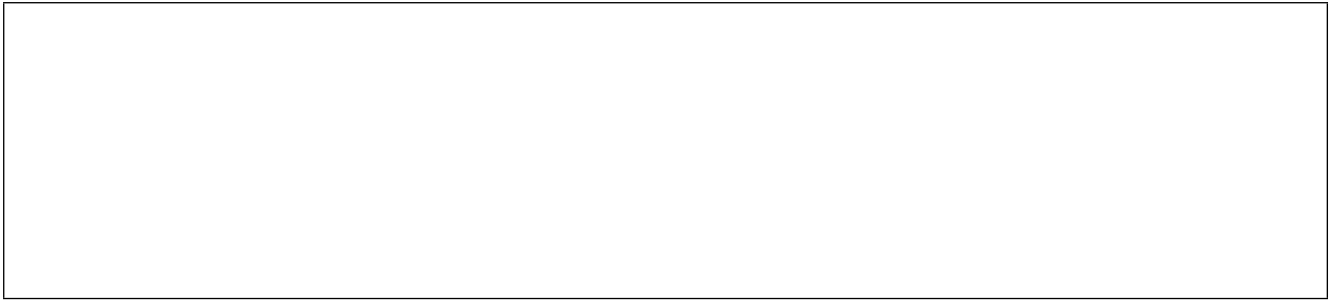
The licence holder shall take and record readings of the meter specified in condition 8 at the same time each day during the whole of the period during which abstraction is authorised or as otherwise approved in writing by the Agency.

A copy of the record or summary data from it shall be sent to the Agency each year, within 14 days of being so directed in writing by the Agency.

Each record shall be kept and be made available during all reasonable hours for inspection by the Agency for at least 7 years.

The records that you have sent to me on the 30/8/22 show that only monthly readings have been taken. Whilst the average abstraction quantities are within those allowed by the permit, there is no way of assessing compliance with the 150 cubic metres per day in condition 7.

this is a breach of your permit, for which there is a Compliance Classification Score of 3 (a breach likely to have a minor environmental impact).
