### 4. Details of our assessment

Following the issue of the EPR Waste Permit on 07/09/2020 by the NRW permitting team, Senior Waste Regulation Officer (NRW South Central Waste Regulation Team) undertook a first permit inspection visit, at Alun Griffiths (Contractors) Limited (the Operator), Rover Way, Cardiff Docks site on 07/05/2021. The site was not operational at the time but it was

still possible to undertake a detailed visit and a CAR report (CAR\_NRW0038393) was issued on 15/06/2021. A follow up visit was undertaken on 18/03/2022 to inspect the site when it was operational.

The Operator was represented by their Future Generations Manager, the Site Manager and the environmental co-ordinator for the Rover Way site during the visit.

The NRW officer carried out an inspection accompanied by the Operator's representatives. The site was operational on the day and the site supervisor was operating the machinery (see photo 1). A discussion was held with the site supervisor to discuss daily process at the site including the process of rejecting/segregating non permitted material at the quarantine area (see photo 2). The site infrastructure was in good condition.

Subsequent to the visit, the following documents were provided by the Site Manager via email as evidence.

1. Copy of waste consignment notes for the quarantine material that was originated from Pontypridd sub-station.

The site recently received a significant quantities of processed material from the Compass Road site (permit number PB3230RV) (the site is in process of being surrendered). The material is currently stored on-site (see photo 3). The site manager confirmed that the material will be consigned shortly and the waste consignment notes will be provided.
