I visited the site today to hand Mr Soper a Regulation 53 Notice for failure to submit Consignee Returns in the given quarters. Q1 and Q2 of 2022 were missing. The site has to provide this information by the 14th of October.

I inspected the yard area which had no waste in. The area has not been used for the previous 3 years but Mr Soper is thinking of starting back up his Asbestos removal side of his business and therefore he wants to keep his permit. I took some photographs of the



yard which I have attached to this CAR.

Mr Roper is awaiting a date for his continuing competency assessment which has been delayed by his assessors. Please forward an email to confirm this by the end of the week (7th of October). The continuing competency needs to be completed asap but before the 4/11/22.
