4. Details of our assessment

Apr – Jun 22

This CAR covers a review of the routine monitoring and reports for the period Apr – Jun 2022 for all permitted emission points.

Emissions to Water (W1)

Although there was no reported lagoon discharge during the period, samples of the lagoon were still taken and analysed. Suspended solids were compliant with the permitted limits during this period.

Emissions to Air**Continuous Monitoring (A5, A8, A9, A15)**

All continuous emissions monitoring was provided as required by the permit and shown to be within the permitted limits during this period.

Periodic Monitoring (A8, A15)

All 6 monthly periodic emissions monitoring was provided as required by the permit and shown to be within the permitted limits during this period.

Other Reports

Alternative raw material / waste derived fuel usage reported as required by the permit. Kiln by-pass dust 6 monthly analysis also reported.

Notifications

NRW received 1 Part A notifications during this period, as required by Condition 4.3 of the Permit.

27/6/22 (20:24hrs)

Part A received 28/06/22. This notification relates to an external power dip resulting in a dust release via Kiln inlet & cement mill 5 stack (50Kg). Brief power dip in the electricity supply to site at 2024hrs causing all systems to trip off. Fans restarted, all items of plant checked and restarted without issue.

Part B received 05/09/2. Scottish Power Control Room reportedly confirmed that their system has pages of alarms for that evening throughout the area (Holywell, Flint, Mold, Deeside, Hawarden etc). They were not sure of the specific fault as this was triggered on the National Grid and not the network Scottish Power are responsible for.

This issue was outside the site's control.

No complaints were received by NRW for this time period.
