4. Details of our assessment

I called into the site as I was passing the area and noticed some yellow bags in skips in the external yard area.

I went to the sites reception area and spoke to Emma Poyer. Emma and Lewis Poyer met

me outside and we walked around the back right hand side of the processing building where I saw 2 skips with tiger bag waste in. These skips were positioned in bays and were not covered. I took a number of photographs of the waste in the skips and gave Emma Poyer a Notice of Powers and Rights.

All waste on site should be stored in a building. as per condition 2.1 and Table S1.1. Please ensure this is put in place immediately and no later than the 7th of October .
