Natural Resources Wales, (NRW), have been informed by Slicker Recycling that the weighbridge at their Newport site failed its recent calibration checks to the extent that a replacement is required. Measures are in place to purchase a new weighbridge, but due to the capital costs this may take a little while.

In the meantime Slicker have agreed to double check the weight of waste sent from Newport to their Stourport site by weighing when the load leaves Newport and weighing it when it arrives at Stourport. A minimum of two loads per week should be checked in this way. It should be possible to estimate the change in weight due to the vehicle's fuel use. Results will be recorded and made available to NRW on request.

NRW are prepared to accept this as a temporary means of recording the amount of waste leaving Slicker's Newport site, but the new weighbridge should be installed as a matter of urgency and be installed and commissioned by 21st December 2018 at the very latest.
