4. Details of our assessment

Q1 & Q2 Monitoring Return Submissions (2022) & Schedule 5 Part A & B Notification

Emissions to water

Data for Q1 2022 (January to March 2022) and Q2 2022 (April to June 2022) has been reviewed. Emissions from W1 tested for Flow, pH, Suspended Solids, Chemical Oxygen Demand, Iron, Chromium, Mercury, Nickel and Zinc. Noted that all measured parameters are below permitted emission limit values (ELV).

Schedule 5 Part A & B Notification

Schedule 5 notification received on 11 August 2022 reporting a skip fire which occurred on 3 August 2022 (18:00). It is reported that the skip fire was started deliberately by trespassers whom accessed the site via a perimeter fence.

Releases included immediate release of smoke plume and steam and residue fire water following immediate response by on site fire service. Fire water released to hard standing and not reported to enter surface water drains.

Actions undertaken by operator as follows:

- Responded to incident in accordance with Facility *Management of the Risk of Fire Protocol Document*
- North Wales Police Informed
- On site enquiry held
- Increased security patrols, particularly at suspected point of entry.

This will be discussed at the next visit.
