4. Details of our assessment

This was a prearranged familiarisation visit and routine inspection of the facility by the Natural Resources Wales (NRW) regulating officers.

The site currently accepts up to 200,000 tonnes of waste per annum; the Operator has submitted a permit variation to increase the annual tonnage throughput.

NRW officers were provided a full tour of the facility with explanations of the relevant process stages and discussed maintenance and abatement. This covered the facility process from receipt, storage and incineration of waste, through to energy generation, surface water discharge and waste management within the permitted area.

A new containment bund has been constructed, the adjacent canopy is to be extended to prevent rainwater ingress. It is expected to be constructed within the next month.

The site was well managed, ordered and tidy at the time of the inspection.

The need for a Schedule 5 Notification for all process shut downs was discussed. NRW agreed that process shut downs that **do not** have an adverse environmental impact do not need to be reported via a Schedule 5 Notification in the first instance. As a minimum the Operator shall advise of the time, date, duration and reason for shutdowns on the CEMS returns and /or email as appropriate.

During the site visit Officers observed that the penstock valve between the surface water attenuation pond and the discharge outlet to the watercourse was set to closed but unlocked. Whilst the penstock is within the site boundary, it is relatively remote and may be vulnerable to vandalism /misadventure resulting in unintended releases.

Subsequent to the site visit the Operator has confirmed that the penstock has since been locked off in the closed position with chain and a padlock. The key will be held by the Environment Manager and the duty shift team leader. The penstock valve status is already checked and noted on the weekly environmental audit. The penstock valve is only opened during heavy rainfall events following a satisfactory visual assessment of a sample for oils and solids as well as a pH measurement (this is also done weekly even if the penstock is closed).
