4. Details of our assessment

Forms W1, Emissions to Water and S1, Emissions to Sewer, for 1st July to 30th September 2022 were received on 4th October 2022.
Both reports are accepted.

W1 Emissions to Water

All parameters were within their respective emission limit values (ELV).
MCERTS does not apply to the pH meter used for these emissions because it is not a portable unit.

S1 Emissions to Sewer

pH and flow were within their respective ELVs.

The ELV for aluminium emissions to sewer was breached on 9th September 2022. A Schedule 5 Notification was submitted and the details can be found in CAR_NRW0040477. A Cat4 non-compliance was issued.

The pH meter used to continuously monitor the discharge to sewer is not MCERTS approved. Following the recent OMA audit, when calibration and maintenance procedures for this meter were reviewed, Natural Resources Wales have agreed to accept readings from this meter as suitable and sufficient.
