4. Details of our assessment

On the 20th of August 2022, Environment Officer Luke Burton and I attended Sugar Loaf Cottages, Abergavenny, NP7 7LA to conduct a routine inspection of abstraction licence: 20/56/31/0111.

I met licence holder, Wyndham Harris and requested to inspect the borehole abstraction and any records. You said that your brother, Frederick Harris, dealt with anything related to

the borehole and that you did not have the key to access the abstraction point, or any records.

You provided your contact details and agreed to provide the information after speaking to your Frederick Harris.

On the 4th of October, I received a phone call from your son. He said that there is no meter on the abstraction point, and has never been. He said that the only purpose the water was used for was water supply for domestic properties. I told him that the licence stated:

'Purpose of abstraction

Commercial: for domestic and bottling water purposes'

I understand that the water has never been used for bottling water purposes and as such the water only supplies a small number of properties for private domestic purposes, and as such would not require a licence.

The licence was applied for by a previous property/landowner with commercial purposes in mind which were never realised.

Action

As the licence is not required, please apply to surrender the permit. This will remove the requirement for any further NRW inspections, thereby allowing more efficient targeting of resources.

I have included information on how to surrender your permit, in the email that will accompany this report.
