4. Details of our assessment

WARNING

On 18th August 2022 my colleague and I carried out a routine inspection to check compliance with licence conditions.

Your Impoundment licence states:

- 4.5 The Licence Holder shall construct, operate and maintain the intake works in accordance with the specifications and drawings referred to in condition 3.1 of this licence and keep them free from leakage and obstruction at all times.

Debris had gathered across the HoF notch impeding the flow of water. This has the potential to cause a significant environmental impact within the depleted reach. However, on this occasion your HEP scheme was not abstracting and some water was flowing downstream. The debris was removed and flow significantly increased.

Please ensure measures are taken to remain compliant with licence conditions and note this CAR form has been recorded as a Warning.
