**4. Details of our assessment**

This Compliance Assessment Report (CAR) follows a routine site inspection at Llay Feed Mill on 28/09/22. The Operations Manager and QHSE Co-ordinator accompanied NRW staff during the inspection.

The site was relatively busy with traffic and the weather was sunny during the inspection.

The site entrance and road leading onto site were clean and there was no evidence of mud.

There were no dust emissions or significant odours (faint smell of animal feed which is to be expected) observed on site.

Waste was stored securely in skips and there was no evidence of pests or scavengers.

Since the last inspection, signage around the site has been updated to include the correct emergency contact number for Natural resources Wales (NRW)- 03000653000.

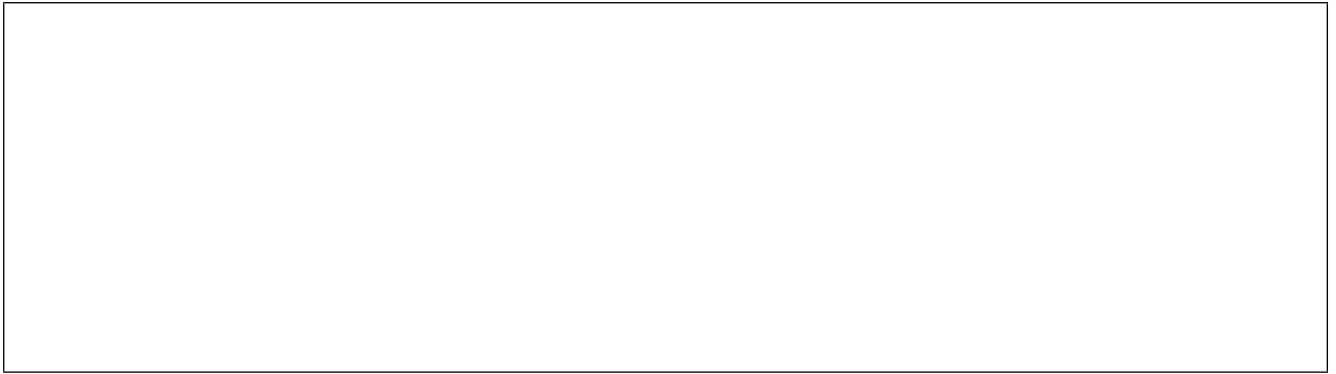
The Operations Manager provided an overview of the Supervisory Control and Data Acquisition (SCADA) system for the feed mill.

As part of the most recent permit variation (EPR/AP337HF/V006) issued 21/01/22, the operator is required to complete a number of improvement programme requirements. Improvement Conditions (IC) 3-5 were due to be completed within 3 months of permit issue and IC10 parts a) and b) were due to be completed within 6 months of permit issue.

These Improvement Conditions have not been completed and submitted to NRW yet. NRW considers this a breach of permit condition 2.4.1 which states 'The operator shall complete the improvements specified in schedule 1 table S1.3 by the date specified in that table unless otherwise agreed in writing by Natural Resources Wales.' (G4-CCS3).

The outstanding Improvement Conditions were discussed with the operator who explained that they were almost complete and were awaiting management sign-off on these. A new deadline of 17/10/22, for submission to NRW, was agreed with the operator.

Action 1: Ensure outstanding Improvement Conditions (IC 3,4,5 and 10 parts a and b) are completed and submitted to NRW by the specified date.
