4. Details of our assessment

Natural Resources Wales Senior Industry and Waste Regulation Officers Phil Harper and Lara Cubley visited Toyota Motor Manufacturing (UK) Limited, Deeside Engine Casting Plant, Zone 3, Deeside Industrial Estate, Flintshire, CH5 2TW, at 10:00 am on the 7th September 2022. This was an announced site inspection.

The site was operational at the time of the inspection.

A1 Specified by Permit

The facility was in a clean and well-maintained condition. Necessary access to emissions monitoring points was provided. All activities taking place at the time of the inspection were covered by the activities set out by the environmental permit.

All points of emission to air were visually inspected. All were in good condition apart from stack 9 which was undergoing routine maintenance at the time of the inspection.

No permit breaches were noted.

B1 Engineering for the Control of Emissions

The site is equipped with automatic pen stock control valves for water emissions from the site.

No permit breaches were noted.

F1 Odour

No offsite odours were noted during the inspection.

F3 Dust/fibres/particulates and litter

No litter was observed outside of the site boundary.

F5 Deposits on road

No deposits were observed on the road.
