4. Details of our assessment

Forms A1, Emissions to Air, W1, Emissions to Water and S1, Emissions to Sewer for 1st July to 30th September 2022, were received on 14th October 2022.

All parameters for emissions to air and to sewer were within their respective emission limit values (ELV).

The emission to surface water exceeded the ELV on 6th July 2022. The concentration was 2.97mg/L; the ELV is 2.0mg/L. A Schedule 5 Notification was received on 2nd September 2022, after EnerSys had received the results of a sample re-test. The matter is dealt with in CAR_NRW0040359.

All the reports are accepted.
