4. Details of our assessment

Form S1, Emissions to Sewer, 1st July to 30th September 2022, was received on 11th October 2022. The average daily discharge was 52.3m³ over 66 days, making a total discharge of 3454m³. The total discharge and daily discharge were higher than in Q2 2022. The site operated for slightly more days.

The report is accepted.

The permit variation, following publication of the BAT Conclusions for the waste treatment sector, introduced new monitoring requirements for GD. The parameters to be measured from 17th August 2022 have not been finalised and so reporting requirements have not yet changed from those in the previous permit.
