Thank you for your application received on 19/12/2018.

We need to ask you for some more information before we can do any more work on it. Please would you provide the following:

- A Manure Management Plan has been referenced in form F1 but it has not been attached in your application email. Please send us this document for assessment.
- Form Part B2: question 3a (relevant offences) is incomplete. Please complete and resubmit the form.
- You have referenced documents for Domgay Hall in form Part B3. Please amend to match this application.
- Nearby Ancient Woodland and Montgomery Canal SAC/SSSI site are identified in the ammonia report, but the Site Condition Report states there are no nearby designated areas. Please amend to reflect these sites.
- Installation plan: please submit a revised version that illustrates the location of all equipment on site e.g. generators, fuel tanks and all emission points to air (fan type and location) for both broiler units. Please remove the hedgerow lines as they are the same colour as the installation boundary and intersect it, which could cause confusion.
- Please merge the revised installation plan (previous point) with the layout plan by adding all the details from the revised installation document to the layout plan, or vice versa. Please ensure hedgerows are removed from the final version.
- Please confirm the crop cycle length and the number of cycles per annum.
