

Hi Fiona,

Our requirements as follows for the additional sites, when you get to the point of submitting the licensing paperwork for them:

Afon Wen: Submission of subsequent reports to RCAHMW

Llanaber: Submission of subsequent reports to RCAHMW

Pwll: Submission of subsequent reports to RCAHMW. I also have a query about foreshore access and whether or not this involves vehicles? There is a fishtrap located on the foreshore adjacent (south) to the works area which would need to be avoided (<https://coflein.gov.uk/en/site/519290>). But reading the description of the GI works, I suspect that this isn't a problem as the GI work seems to be to either end of the sea defence and I assume (?) that access is via land to the sampling point.

Tywyn: Submission of subsequent reports to RCAHMW

In all cases there is no available evidence to cause us to expect there to be any impact to archaeological material. As before, submission of the reports is useful because it can potentially inform of the depth of any peat deposits that might be included in the coring/sampling work. A caveat to all of this is that there is always a chance (albeit small) of finding some unexpected/unknown archaeology, and in that case I am happy to act as a point of contact in the first instance.

We can supply copies of reports for each location and I will forward these on to you once complete.

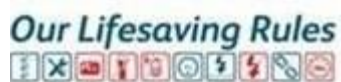
