2021 Annual Report topographical survey

Review of topography survey drawings against the Pre-settlement plan confirmed that the tipping heights of some cells are in excess of the agreed levels. Whilst this inconsistency amounts to a non-compliance, remedial action is now ongoing.

We will look at tipping heights again as part of your 2022 report.
