Any non-compliance we have identified and recorded on this form is an offence. It can result in criminal prosecution and/or suspension or revocation of your permit.

4. Details of our assessment

Natural Resources Wales received intelligence which suggested that the permitted site 'GTR Aggregates & Recycling Ltd' had been repossessed by the landlord and that the operator no longer had access to the site.

Contact was made with the landlord who agreed to meet with NRW Officers on site.

The gates were secured and large concrete blocks had been placed either side of the gates to prevent vehicular access.

Officers had a brief conversation with the landlord who explained that he had the site repossessed on Friday 7th October, from which point GTR Aggregates & Recycling / Think Recycling, no longer had access to site.

Officers had a walk around site to check for any changes or any environmental concerns. The site appeared to be in the same state as the previous inspection. The waste remained clear of Household, Commercial & Industrial wastes other than a few skips in the transfer building and recycling building.

There were still approximately 5 piles of inert waste that did not look as though any had been added/ taken away since the previous inspection.

The landlord explained that the site would remain secured and within his possession. No other party has access to the site. It was agreed that the landlord and NRW Officers would communicate accordingly to ensure the site remains secure and that any remaining waste is suitably removed to authorised facilities.

Permit Condition 1.1.4 The operator shall comply with the requirements of an approved competence scheme.

On 5th October 2022, NRW received formal notification from Technically Competent Manager (TCM), Andrew Tabinor, that as of Monday 3rd October, AC Environmental ceased providing TCM cover for the site.

Despite attempts being made to contact the permit holder, NRW has yet to receive confirmation of whether a new TCM has been found for the site.

As the site is without a TCM and therefore not complying with the requirements of an approved competence scheme, the site has been scored a CCS C3 score for this non-compliance.

This score means that there is potential to have a minor environmental impact through a lack of compliance with an approved competency scheme. There is minimal Household, Commercial & Industrial waste on site and so there is only inert waste currently being stored. The permit remains suspended so no new waste should be entering site. Therefore, as operations are somewhat reduced, the potential risk to the environment is currently low and is reflected in the C3 score.

Action: A new Technically Competent Manager must be acquired for the site to ensure compliance with the requirements of an approved competence scheme. Please note, no treatment of waste should take place on site until a new TCM is found for the site.
