4. Details of our assessment

This Compliance Assessment Report follows a routine site inspection and meeting primarily focussed on arrangements in place ahead of site closure and permit surrender.

At the time of writing the operator advises that some manufacturing activities have already ceased or are being wound down.

NRW wrote to the operator 04/10/22 to highlight the company's ongoing responsibilities until such time that the permit is surrendered.

It was agreed that the operator will supply NRW with a decommissioning plan for the facility - please submit by 04/11/22.

OMA Actions / Effluent Emissions Monitoring

As discussed, following the cessation of production and the decommissioning of plant (removal of potentially polluting substances) it may be acceptable for the operator to review the existing emissions monitoring regime and taking a risk-based approach seek agreement to an alternative regime until permit surrender is achieved.

This may potentially include a reduced number of composite samples and the analysis of all samples at a UKAS accredited laboratory to address previous actions relating to use of in house methods. It was agreed that existing continuous flow, temperature and pH monitoring should be retained until permit surrender.

Responses to the 2021 OMA Water audit were discussed, NRW is satisfied that adequate responses have been received and in lieu of site closure we refer comment above re. review of effluent emissions monitoring provisions going forward.

The operator is also in the process of reviewing options for surface water drainage post permit surrender.

Noise & Odour

Some minor localised odours were noted on site that were unlikely to lead to an offsite impact, an offsite check did not identify any odour. A brief assessment of noise was completed close to Wirral View, the site was occasionally audible above road traffic noise but the sound level and character was not likely to constitute a pollution at this time.

No significant issues were noted during the site inspection
