4. Details of our assessment

This compliance visit was carried out by Malcolm Dines and Jeremy Goddard who met Darren Lovatt (Director and TCM) who accompanied the officers on the visit. A full assessment of the site was undertaken, the weather was dry and cloudy.

At the time of the site visit the new grab for the site was being repaired and this had caused a backlog with some of the waste stockpiles at the site. It was explained that although the stockpiles looked large, as soon as the grab was fixed it would move the material very quickly. The repair was expected to be completed the same day as the site visit and the backlog was anticipated to be cleared quickly. It was also noted that you had two new machines on order.

Waste Returns for the site for the 12 months from July 2021 until June 2022 were reviewed after the site visit. All wastes reported as being accepted at the site are authorised by the permit and there was no evidence that any tonnage limits were exceeded during the 12 months period under review.

Permit Breaches

C2 - Management system and operating procedures - Cat 4; Permit Condition 1.1.1

You have been given this category 4 breach under the above condition because during the inspection it was identified that the site noticeboard was out of date. You must update the noticeboard and ensure that it is easily readable from outside the site in daylight hours and must include:

- the permit holder's name (company name at least) • the operator's name if different (company name at least)
- an emergency contact name and the operator's telephone number
- a statement that the site is permitted by Natural Resources Wales
- the permit number
