NRW received notification from Celsa (Email dated 7th September 2018) that the Mineral Site contractor HARSCO needs to carry out lancing external to the booth as the items are too large to move into the booth. This is a normal occurrence but the permit requires written agreement (Permit Condition 2.3.7) from NRW prior to commencement.

Permission is granted for the activity on the basis that measures are adopted to avoid off-site environmental impact. This should include the use of water sprays as necessary and consideration of the wind direction at the time of lancing. In the event of potential off site impact the activity must be suspended.

External lancing is permitted to commence on Friday 21st September 2018 and last for six weeks (finishing on Friday 2nd November 2018).
