4. Details of our assessment

Officer Chris Burge attended at Volehurst Limited to complete a routine compliance inspection of the permit **EPR-KP3595FB** on Thursday 20th October 2022. Weather was cool and dry.

SITE OVERVIEW

Officer Burge completed a short walk over of the site with company director Mr Webb. Mr Webb gave details on recent activity of the site, site operations and destinations for outgoing waste streams. All mechanical and hand sorting of waste was being completed on the area of impermeable surface. No issues were noted regarding infrastructure or the storage of wastes on site. Site diary was inspected and appeared to be in continuous use. Duty of care waste transfer notes were briefly inspected, no issues apparent.

The site operates on a concrete hard standing which was in good condition with no damage as seen below in picture 1



The site has a drainage system all surface drains lead to an interceptor and then discharge with consent to Welsh water foul lines

Mr webb explained waste comes in and is hand sorted by staff, the inert waste is stock piled and his digger is on top of this to assist in loading in to the lorry to removal, waste is not stored for any length of time it's a very fluid in and out system.
