CQA Proposal – Capping of Sub-Cell 1 – Record of Acceptance

Permit condition 2.5.5 requires TATA to submit construction proposals, prior to the construction of any landfill infrastructure. Construction should not commence until Natural Resources Wales (NRW) has confirmed that it is satisfied with the construction proposals.

Tata have submitted construction proposals for the Capping of Sub-Cell 1. The construction proposals consist of the following documents/submissions:
