## 4. Details of our assessment

This report details the site visit carried out on Tuesday 4 October 2022 at BIFFA, The Recycling Centre, Dyffryn Business Park of the permit EPR-XP3295FK. Officers Carla CURTIS, Alex BOWDER attended the site at 13:30 to complete a routine compliance inspection. Weather was overcast and dry, Officers met with Kathryn EVANS (TCM and Site Manager) who accompanied officers around the permitted area.

### **ACTIONS FROM LAST SITE VISIT**

15 February 2022 - No actions required from last visit.

To remind the company following each visit Natural Resources Wales will produce a Compliance Assessment Report (CAR) detailing our comments from the inspection. If we substantiate reasonably foreseeable risks or actual impact to the environment, we can breach the business against your permit conditions which can affect your site banding and annual subsistence fees; this is scored on a Category 1 - 4 basis:

- 1 - Major, serious persistent and/or extensive impact on the environment/people/property
- 2 – Significant impact on effect on the environment/people/property
- 3 – Minor impact or effect on the environment/people/property

4 – A non-compliance which has no potential environmental effect

### **GENERAL OBSERVATIONS**

Officers received a site tour, and the following observations were made. Waste streams were segregated, with mixed waste material stored inside, and construction and demolition waste outside. General waste was previously deposited centrally outside within the site. This area is now free of waste with a makeshift roundabout for vehicle movements. The operator spoke about constructing bays for waste storage going forward.

### **PERMIT**

Officers raised the issue surrounding the age of the permit, and the old-style conditions / wording. The permit does not have a modified section for fire risk and associated fire prevention and mitigation plan. It was noted that a lockbox was present on the outside of the office building containing emergency fire plan documents for the SWFRS - it would be useful to observe these on future compliance inspection later in the year, along with the current EMS document. This was good to see.

Officers noted that there was a larger stockpile of plasterboard present on site. This was stated to be due to the current waste market and issues with outlets across the UK.

### **INFRASTRUCTURE AND DRAINAGE**

The site is situated on an impermeable base, which appeared to be in good condition. The site drains to an interceptor, which is serviced every six months and emptied when required. The site also has a discharge point to the Rhymney River. Issues at the sample point were noted last year and an extensive clean out of the interceptor was undertaken. The sample point is managed by the local environment team.

### **Technical competency**

The site TCM is Kathryn Evans. The latest WAMITAB certificate we have on the system for Kathryn Evans was issued 02/11/21.

### **Waste returns**

Waste returns must be submitted to NRW quarterly, within one month of the end of each quarter. Kathryn Evans is responsible for submitting waste returns for the site. The maximum total quantity of waste accepted at the site per year shall not exceed 74,99 tonnes. Waste returns appear to be up to date and within permit limits. Please continue to submit these in line with your permit. On 27/07/22, correspondence with Biffa Waste Services indicated that their waste returns were submitted on time and in full with a total of 6838.78 tonnes received during Q1, 2022 with 5973.82 tonnes removed.
