4. Details of our assessment

Liz Park (Senior Officer - Waste Regulation) and Gillian Coates (Officer - Waste Regulation) arrived at the site the undertake an unannounced site inspection focusing on what steps had been undertaken since the last compliance visit. Liz and Gillian met with

John Adams, Operator and TCM

At the time of the inspection the weather was warm and dry.

Weighing Inert Waste

John Adams informed Liz and Gillian that he was now weighing all inert waste that left the transfer station and was going to the landfill for daily cover. This will ensure that your waste returns for waste accepted and removed are accurate and will enable you to ensure that you remain within the limits specified in this permit for the acceptance and storage of inert waste.

Sorting Line

At the time of the inspection, the incoming waste was being sorted with a grab due to the current sorting line being out of action. John said that the current sorting line was not suitable and that he was going to be installing a bespoke line.

Working Plan/ Management System

On CAR_NRW0039174 you were asked to review your Environmental Management System with regards to the management of Inert Waste. It is understood that no changes have yet been made. Please review and update your working plan/ management system and provide a copy to NRW for review by 25 November 2022.

Dust

At the time of the inspection, it was noted that the site was very dusty. The spell of continuing dry weather would have been a contributing factor. Whilst a dust emission was not found on this occasion you must ensure that if needed you take steps to manage dust as detailed in '181009 RFI JLA_RESPONSEv2 - Response to question 11 regarding dust management' listed in table 1.12 operating techniques.

Fire prevention and Mitigation Plan

Permit condition 4.10.1 requires that *'The operator shall manage and operate the activities in accordance with a written fire prevention plan using the current, relevant fire prevention plan guidance'*. A draft Fire Prevention and Mitigation was plan submitted by your consultants in May 2019. For various reasons this has not be fully reviewed. This review is now being undertaken, and our response will be sent to you on a CAR in due course.
