4. Details of our assessment

On the 13th October 2022 Environment Officers Cathrine Kiely and Stuart Jones

responded to an environmental incident (WIR ref 2207233) at an unnamed stream, Treborth, Bangor, Gwynedd.

Assessment of the final effluent quality of the consented discharge from Ceris Newydd nursing home, Treborth, Bangor, LL57 2RQ was undertaken and sewage fungus could be seen below the outfall pipe for approximately 10m downstream as the stream joined the Menai Straits. There was also a strong sewage odour coming from the final effluent pipe.

Officers took a sample of the effluent discharging and following laboratory analysis received a result of 72.1 mg/l BOD. The consented limit of BOD is 20mg/l meaning the quality of the effluent is almost 3 times the consented limit. The Menai Straits is a very sensitive waterbody as it is a designated SAC (Special Area of Conservation), designated shellfish bed and SPA (Special Protected Area) and increased bacterial levels can impact negatively on these features.

Permit condition 1.7.1 a)The Discharge shall not contain more than:20 milligrammes per litre of biochemical oxygen demand (measured after 5 days at 20oC with nitrification suppressed by the addition of allyl-thiourea) - CAT 3 breach

Action: Please ensure the package treatment plant is serviced and maintained and the root cause of the issue identified and rectified to achieve compliance with consent and minimise the pollution risk to the environment. Deadline: 27/11/22

Due to the breach of Environmental Permitting Regulations (2016) a warning letter will be sent separately to this CAR form as the enforcement response. Further non-compliances with your permit could cause NRW to consider escalating our future enforcement response.
