## 4. Details of our assessment

In July 2022 it was proposed to temporarily move the final sample point to the discharge point of the second sewage treatment plant.

Due to the size of the access chamber, it is not possible to obtain a sample without the sides or bottom of the chamber being touched with the sampling equipment.

As such I do not believe it is possible to obtain a representative sample from this chamber in its current design.

Therefore, a suitable sampling location is required.
