CAR form **CAR_NRW0040098** highlighted that you were not compliant with your permit and a permit variation would be necessary to bring your operations back into compliance. This is to confirm that we received your application to vary to your permit at the end September, and so consider you to be compliant with this issue.

Just a reminder that all poultry litter sent to the Anaerobic Digester is classified as waste. If

you have not already done so, please ensure that Duty of Care / waste transfer notes are produced and kept for your records. An annual waste transfer note is acceptable but must be renewed on an annual basis.
