## 4. Details of our assessment

During a routine visit to site on 12 October 2022 to discuss the recent ERV opening, recent emissions exceedances and to review training records it came to light that waste had been used as part of the Start Up process on the incinerator during the last month.

When reviewing the temperature records relating to the ERV being manually opened during the shutdown to ascertain at what temperature it was opened, it was noted that the kiln was getting up to temperature more quickly on start-up. NRW were informed that floc and blue bins were used in order to get the kiln up to temperature.

Chapter IV of IED does not allow waste to be used during start up. Upon further investigation it has become apparent that the following breaches of the permit have occurred:

Condition 2.1.1 states: *The Permitted installation shall, subject to the conditions of this Permit, be operated using the techniques and in the manner described in the documentation specified in Table 2.2.1 or as otherwise agreed in writing by the Agency in accordance with conditions 1.5.1 and 1.5.2 of this Permit* - **this has been scored a category 2 breach of condition 2.1.1 as the Operator is not operating in accordance with the techniques referred to in the permit application.**

Condition 1.3.1 states: *Without prejudice to the other conditions of this Permit, the Operator shall implement and maintain a management system, organisational structure and allocate resources that are sufficient to achieve compliance with the limits and conditions of this Permit* - **this has been scored a category 3 breach of condition 1.3.1 as the Operator is not following their own Start Up Procedure (document SWP 1.0) provided to NRW on 04/07/2022 that states waste shall only be charged when stage 2 over 850°C.**

Condition 2.3.2 states: *Requires the Operator to ensure that the permitted installation is supervised by staff who are suitably trained and fully conversant with the requirements of the permit* - **this has been scored a category 3 breach of condition 2.3.2 as the Operatives at the site are not complying with the operating techniques or procedures.**

NRW issued a Regulation 36 Statutory Notice on 20/10/2022 stating that the above conditions needed to be complied with.

NRW are also issuing a variation to the Permit to update Condition 2.1.7.
