## 4. Details of our assessment

Thank you for making me welcome and showing me around Racecourse Poultry Unit on October 4th.

I can confirm that the 4-year review for efficient use of energy and raw materials (which includes water use & waste) was received in May 2022 and is compliant.

I can also confirm that the Improvement Programme report showing your compliance to the Best Available Techniques under the BREF Report 2017 (link above), as specified in your permit, was received by NRW in 2021 as required and is acceptable. Just a reminder that when reporting to NRW in January 2023 you will be required to include phosphate and nitrogen emissions in your Emissions Returns as well as ammonia. How to calculate these can be found in section 5.4.9.1 of the above report.

### **Non-Compliances**

1. Amend the notice board at the entrance to the site so that it shows only NRW's 0300 065 3000 incident response phone number and not the old 0800 number. Please update this as soon as possible (by the end of November at the latest) and send me a photo to show that it has been done.
2. Update the list of emergency phone numbers in your Accident Management Plan so that the correct phone Incident Response phone number is listed for Natural Resources Wales

A reminder that under the new Agri-regs: Water Resources (control of Agricultural Pollution) Regulations (Wales) 2021 [The Control of Agricultural Pollution Regulations \(gov.wales\)](#) the wash water will be classed as slurry from January 2023 and will have to be treated as such. The primary issue for you is likely to be a change in the coding on the Duty of Care Waste Transfer notes, however it may have a more substantial impact on the recipients of the wash water (collected after cleaning the chicken sheds at the end of a crop) who will need to know the nutrient levels in the water as they will need these figures to complete their Nutrient Management Plans.

Similarly, if in the future any of the chicken litter is delivered to farms in Wales they will need to know the N and P content of the litter for inclusion in their Nutrient Management Plans. I understand that currently it is delivered to power stations in England.
