4. Details of our assessment

On the 26th of October 2022 a routine sample was taken from the discharge point serving the Star Inn.

Permit condition 1.6.2 states "as far as reasonably practicable the sewage treatment plant shall be operated as to prevent the discharge from containing any significant trace of visible oil and grease".

At the time of our visit, oil and grease were visible, breaching your permit conditions.
