4. Details of our assessment

CAR form **CAR_NRW0040283** highlighted that you are rebuilding Shed 2 to different specifications to the original and that this would mean that you would not be operating in compliance with your permit. We required you to submit an application to vary your permit to bring you back into compliance. NRW has now received your application, and so I would

like to confirm that although it may take some time for the permit variation to be processed, I now consider that you are compliant again in this matter.

I would like to take this opportunity to remind you that under the new Water Resources Control of Agricultural Pollution Regulations 2021:

<https://gov.wales/sites/default/files/publications/2021-01/the-water-resources-control-of-agricultural-pollution-wales-regulations-2021.pdf> there is a requirement that from 1st January 2023 all farmers produce a Nitrogen Management Plan, for their land. If any of your chicken litter is spread to land from January 2023 onwards, it must be planned into the Nitrogen Management Plan before spreading commences.

Poultry manure can be stored as a temporary field heap prior to spreading but must be covered to reduce leaching by the rain, and to reduce loss of Ammonia to the air. From 1st August 2024 additional rules apply to chicken litter, which will then be classed as a high nitrogen content manure and will be subjected to closed periods during which it cannot be spread. The dates vary depending on soil type and crop type.
