4. Details of our assessment

A routine Water Resources inspection was carried out by Heidi Markham from the Ceredigion Environment Team on 2nd September 2022.

Source of Supply and Point of Abstraction

The water is abstracted from the Nant Cwm-du at Ty Mawr, Cwmystwyth, Aberystwyth at National Grid Reference SN 81285 74352. The abstraction point is shown in Figure 1.

The scheme was not operational at the time of the visit due to low flows in the Nant Cwm-du.

No issues were identified.

Means of Abstraction

Water is abstracted by intake works and a gravity feed pipe which is controlled by a spear valve.

No issues were identified.

Purpose of Abstraction

All water is abstracted for the production of power.

No issues were identified.

Means of Measurement

The Licence Holder shall determine the quantity of water abstracted by reference to the kilowatt-hours generated. The turbine and meter, stored in the Turbine House, were not inspected during this visit.

Further Conditions

All water abstracted is returned to Nant Cwm-du at National Grid Reference SN 81129 74791. Figure 2 shows the outfall at the time of the visit.

No water was seen coming from the outfall as the scheme was not operational at the time of the visit.
