I can confirm that the 4-year review for efficient use of energy and raw materials (which includes water use and waste) was received in May 2022 and is compliant. This was highlighted as outstanding issues on CAR Form CAR_NRW0039545 (link below)

I can also confirm that the Improvement Programme report showing your compliance to the Best Available Techniques under the BREF Report 2017 (link below), as specified in your permit, was received by NRW in 2021 as required and is acceptable.
