Further to the previous CAR sent on 28th October 2022, whereby you were informed oil and grease were visible in the discharge, analysis has also shown the same sample taken on 26th October 2022 has also breached:

Condition 1.6 - Composition

B.O.D - Maximum 20mg/L - Result = 67.5mg/L
Suspended solids - Maximum 30mg/L - Result = 84mg/L

Please take measures to prevent a recurrence by 28th November 2022 and submit your actions to me via the email address below.
