On 10th October 2018 Natural Resources Wales (NRW) received a Schedule 6 Notification from Kennametal that the emission limit value (ELV) for particulate emissions from emission point A6 had been exceeded on 13th September 2018.

The ELV for particulates emitted from A6 is 25mg/m³, the emission was measured as 26.67 +/- 2.09mg/m³. A non-compliance will not be issued in this case as the exceedance is less than 30% of the ELV.

This is an on-going problem and despite various modifications to the oven and abatement equipment it does not seem to be improving. Consequently a meeting between NRW and Kennametal has been arranged for 28th November 2018 to discuss the next steps.
