This compliance report details the site inspection conducted by Natural Resources Wales (NRW) Officers on

21 June 2022 at: Silent Valley Waste Disposal Ltd, New Vale HWRC, Waun-y-Pound Industrial Estate, Ebbw Vale, NP26 6XQ Permit number **EPR-RP3895FN**

Waste Regulation Officers Jak ROSE and Senior Officer Alex BOWDER Arrived at site at 14:20 and met with Gavin JEFFREYS, Site Chargehand. The last inspection was completed on 18 June 2018. It was requested that a walk around the entire site would be completed. The weather conditions were warm and dry during the time of inspection.

Officers signed in at the site office at the entrance of the site. Gavin was unable to accompany Officers during the site visit, any questions regarding site operations were left until Officers had completed the site walk around.

The site was free of litter. The condition of the yard appeared to be in good condition, no cracking or damage to hard standing.
