4. Details of our assessment

LW met HS at Singleton hospital to discuss the way forward with the environmental permit. There has been an issue with the lack of refrigeration within the waste compound for anatomical waste. The hospital had explored a number of solutions. The purchase of a refrigeration unit was looked into and the cost of this has been deemed too expensive.

The hospital has amended their internal procedure to state that anatomical waste will only be delivered to the waste yard on the scheduled day of collection a Maximum of 8 Hours before the scheduled collection.

At Singleton the waste can be returned to its department of origin, however they do not foresee any issues necessitating the return of the waste, as they would have received notification from Stericycle of any cancelled collections / significant delays.

Once in the waste yard anatomical waste will be collected as a priority by Stericycle.

This is an acceptable outcome. There have been no issues with odour or vermin so NRW will continue to monitor this process of storing the anatomical waste to ensure there is no environmental impact.

LW discussed the sites OPRA score with HS. We went through the process of assessing this in the light of any application for surrender of the permit.
