4. Details of our assessment

This CAR relates to Q3 Monitoring for 2022.

The Q3 returns for emission point W1 were received on the 26 October 2022.

Monthly monitoring for September 2022 was not undertaken until 11 October 2022 and was therefore outside the frequency specified in Condition 3.3.1 of the Permit.

All parameters were within the emission limit values as set out in the permit.

Advice and Guidance

- Monitoring is to be undertaken in accordance with the frequencies specified in the Permit.
- Procedures must include a contingency to ensure that specified frequencies are met. Natural Resources Wales are to be informed, along with any justification, for any future delay to monitoring.
- The Permit requires twelve data sets to be returned for water monitoring during 2022. The monitoring results provided during October 2022, will be taken to correspond to monitoring requirements for September 2022. Additional monitoring for October 2022 will be required for the Q4 returns.
