4. Details of our assessment

This Compliance Assessment Report follows a routine inspection of the HDU and Waste Transfer Station on 7 November 2022.

Following a meeting with the Operations Director, SHEQ Director, Site Manager and SHEQ Lead discussing recent CAR actions and notice requests, a site inspection was undertaken.

The HDU has had significant modifications made to the external appearance of the plant. A new steel cover has replaced the previous lagging and there was a notable and substantial reduction in fugitive emissions.

It was noted that the yard area was more organised than on previous visits. The Operator stated that they were discussing with the Local Authority the possibility of utilising the rear gate that leads onto Abbey Road South. This would enable a one-way system to be put in place for vehicles, thereby allowing further segregation of bins within the yard area. NRW were supportive of this proposal.

The Operator has undertaken investigations into the surface water drains on site. Further surveys and maintenance are being scheduled following concerns raised in previous CARs.

As there are a number of actions linked to surface water drainage on previous CARs these have been superseded and consolidated into the action below.

Action 1: Provide NRW with an update into your investigations relating to the surface water discharge, including the use of the penstock and any changes made to relevant procedures by 31 January 2023.

A new concrete pad has recently been laid adjacent to the office portacabin to the west of the site. It was noted that water was pooling in one corner of the new pad. The Operator stated that they will get the contractor out to repair / re-level the concrete to ensure the falls are corrected and kerbing is adequate.

Bags of refractory cement were being stored on unmade ground next to the concrete pad.

These bags were split and had the potential to contaminant and seep into the ground / controlled water. This refractory cement was removed following the visit and a photo supplied to demonstrate this.

The Operator also stated that this pad was only for the use of empty bins, however, there were two used sharps containers in this area, not contained within yellow wheeled bins and adjacent to the refractory cement. **This has been scored a category 3 breach of conditions 2.3.1 (Operating Techniques) and 1.1.1 (management systems) - (storage C4).** The containers were removed during the inspection.

We were informed that this area does not currently form part of the routine checks undertaken at the site. **This has been scored a category 3 breach of condition 1.1.1 - (management systems C2).**

Action 2: Procedures and inspection sheets should be updated, with training provided to staff who undertake this role. This should be rolled out as part of the more comprehensive review of training needs and implemented by 31 January 2023.
