4. Details of our assessment

This was a prearranged familiarisation visit and routine inspection of the Facility by Natural Resources Wales (NRW) regulating Officers.

A short introductory meeting was held with Sally Davies and Fiona Montague. An overview of the Facility process was described and key individuals /points of contact at the Facility confirmed. Permit Improvement Conditions (IC7, IC8 & IC9) were also discussed. It was agreed that the requirements of IC9 have been met; IC7 and IC8 are in progress.

NRW officers were provided with a high-level tour of the Facility. Overall, the Facility was well managed, ordered and tidy at the time of the inspection. The following was noted:

- The "aco style" drains on the edges of the vehicle washdown area were heavily silted.
- Roller shutter doors were open during the loading of a wagon on the outgoing weighbridge.

Action: The washdown area should be inspected and where necessary maintained regularly to minimise excessive silt build up and minimise it entering the surface water drainage system. The procedure for maintaining the washdown area should be reviewed and forwarded to NRW by 31 January 2023.

Action: Provision should be made to ensure all wagon drivers are aware of the need to shut the roller shutter doors prior to wagons being loaded. Consideration should be given to improved signage, training and/or change in procedures at the weighbridge.

Advice and Guidance

The Operator stated that previously spill kit bins had been misused and contained litter. Consideration should be given to improving training, signage or alternative means of storage of spill kits to prevent them being used as waste bins.
