4. Details of our assessment

On the 25th July 2022, we received a pollution report from DCWW that there was a burst on their short rising main between their pumping station (SM 89953 06433) and the entry to the STW (SM 90065 06506).

This site was attended by Chris Roscoe, Environment Officer on 08/08/2022 for further investigation. The report stated that the burst issue was resolved by switching off the pumps at the SPS and manually tankering effluent through the site up to the STW entry. The flow into the site exceeded the capability of this process and therefore excess effluent began to load the storm tanks and eventually was released through the final effluent line, and into the estuary. This material was untreated and unscreened. The pipe breach was resolved the same day and the pumps brought into operation.

This activity however has led to breach of permit condition. This non-compliance report is issued with regards to the damage caused to the environment due to the pollution incident.

NRW requires you to take the following actions to avoid further damage to environment.

- Improve the infrastructure - repair assets and operations on site
- Take necessary measures to resolve this issue and prevent further damage to the estuary
- Prepare a accidental discharge plan to avoid future problems
- Comply with permit conditions
