### 4. Details of our assessment

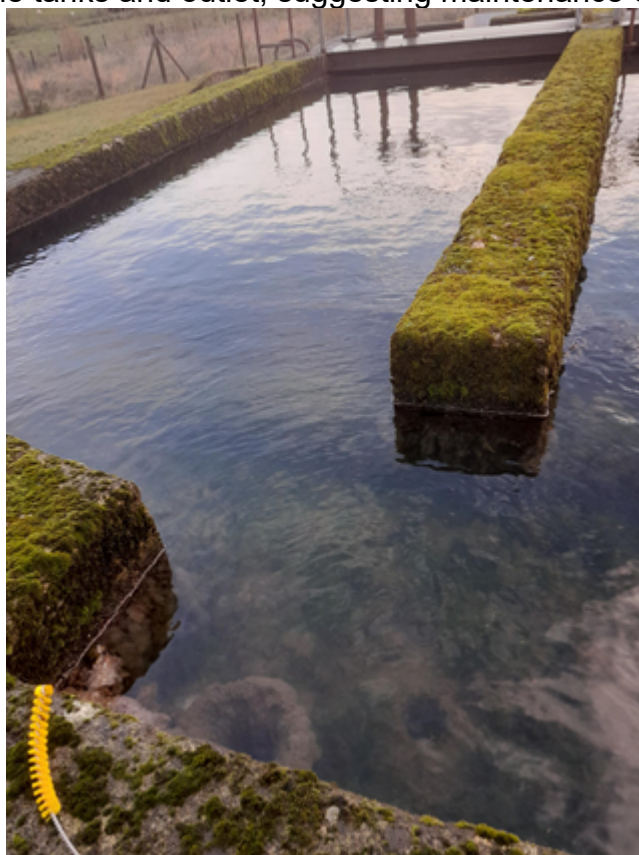
On Tuesday the 8th of November 2022, NRW officer Nathan Owen accompanied by Cathrine Kiely and Simon L Roberts carried out an OSM (operator self-monitoring) visit to the Cwm Penmachno Sewage treatment works (Permit Id CG0076501).

NRW was accompanied by the DCWW catchment manager Victoria Collier and Brent Parry, supervisor for the Conwy area.

The weather was cold and windy although it was not raining it was evident the area had

suffered with frequent heavy rain prior to our visit to the site.

The site was operating as normal with effluent being passed forward on inspecting the settlement tanks it was evident that the primary tanks had excess organic matter growing within the tanks and outlet, suggesting maintenance of the primary tanks had not been



regular.

The single filter bed on site was operating as normal, however it was noted that there was excessive grass growth on the surface of the filter bed suggesting asset had not received sufficient maintenance recently.

The MCERTs calibration was in date with a valid calibration certificate in place. Date of last calibration 19/02/2021.

Date of next calibration 19/08/2023.

The data on the MCERTS is within consented limits.

The storm tanks at the site were spilling at the time of our visit and no EDM seen was on site. NRW were informed by DCWW it can take up to 48 hours for storm effluent to be returned to the works following a storm event.
