Any non-compliance we have identified and recorded on this form is an offence. It can result in criminal prosecution or civil sanctions being imposed depending on the circumstances of the offence.

4. Details of our assessment

On the 11th of November 2022, I attended the intake structure for abstraction licence: WA/056/0032/002 to confirm completion of actions associated with a previous inspection on the 1st of October 2022.

The weather was dry at the time of the inspection, following a period of average rainfall for South East Wales throughout October and November. Water resources for the region has recently entered 'Recovering Drought' status, following a very dry summer.

The bypass pipe that was conveying 100% of the watercourse flow during the last inspection has now been blocked following the completion of maintenance works to the offtake pipework.

During the inspection water was flowing through the hands off flow notch (HoF) as well as over the abstraction screen. This allowed confirmation that the HoF was capable of maintaining the required 10 Litres/second flow downstream.

The build up of silt upstream of the weir was still in place, however this is currently not impeding the flow of water over the screen or through the HoF. **This situation must be monitored to ensure that at no point does silt/mud deposits, or any other blockage prevent water flowing preferentially through the HoF.**

Following the issue of CAR_NRW0040514 on the 24th of November, I spoke to Mr Price, the operator, who confirmed that the meter was original, installed at the time of construction, however that when the meter reaches 100,000 it reverts back to 0. Mr Prices records cumulative figures, taking this into account.

As previously stated: In the future, please notify NRW when intending to use the bypass pipe to conduct maintenance works and agree a timeframe.
