2. What action is required?

No action required.

3. What will happen next?

Any non-compliance we have identified and recorded on this form is an offence. It can result in criminal prosecution and/or suspension or revocation of your permit.

At this time, we do not intend to take any further action.

4. Details of our assessment

Several actions were identified during Natural Resources Wales' (NRW) site visit on 15th June 2022. They are described in CAR_NRW0040027.

Action 2: Add sulphuric acid (H₂SO₄) tanker deliveries to procedure ECM00606. To be completed by 15th July 2022.

A modified procedure was received on 15th July 2022. It is clear and comprehensive, adding procedures for H₂SO₄ and sodium hydroxide deliveries and collection of waste acid.

Action 2 has been completed and can therefore be closed.

Action 3: NRW to be provided with copies of the contract, a full monitoring report and the laboratory analysis report. This could be completed as part of the planned operator monitoring assessment (OMA).

Documents were seen during the OMA audit on 26th October 2022.

Action 3 has been completed and can therefore be closed.

Action 4: EnerSys to verify that the testing laboratory is accredited for the analysis that they require. Forward the details to NRW by 29th July 2022.

NRW received copies of the testing laboratory's Schedule of Accreditation and a copy of a certificate of analysis on 18th July 2022. Documents were also reviewed during the OMA audit on 26th October 2022.

Action 4 has been completed and can therefore be closed.

Action 5: Attach instruction to purge the sampling pipe, before taking a sample, on or near the manual pump and add instruction to procedure. Send photographic evidence to NRW by 24th June 2022.

Photographic evidence was received on 23rd June 2022 and the final version of the modified procedure was received on 27th June 2022.

Action 5 has been completed and can now be closed.

Action 7: Inspect all of the bunded oil storage containers. Empty the bunds. Replace or repair those that are damaged. Send NRW photographic evidence that this has been completed by 16th September 2022.

Photographic evidence was received on 15th September 2022 and the containers were inspected during the OMA audit on 26th October 2022.

Action 7 has been completed and can now be closed.

Actions 2 - 7 were all completed within the specified timeframe.

Actions 1 and 6 remain open.

Action 1 requires EnerSys to audit their red lead supplier by 31st December 2022.

Action 6 requires EnerSys to send NRW a description, operating procedures and maintenance regime for the new oven at least two weeks before it is operational.
