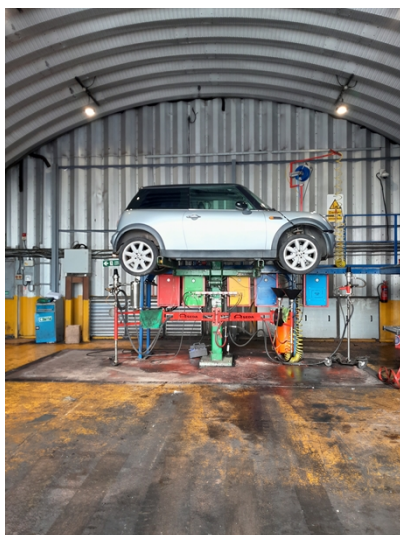

The main purpose of the visit was a routine site inspection.

Depollution of End-of-Life Vehicles

All depollution of vehicles takes place in a designated building under cover. This is located separately to the other waste fractions on site covered under permit number **EPR-FP3094VP**.



Vehicles awaiting depollution are stored on an impermeable surface.

All associated wastes (i.e. hazardous oils, coolants etc) were contained within an undercover bunded area to the right of the depollution area. Batteries removed during the process are stored in a suitable container. Catalytic converters were also being stored appropriately and were bar coded for ease of tracking.



Tyres are stored in an allocated skip and removed to an authorised facility once a high enough tonnage is reached.

At the time of the inspection the depollution bay was not being used and maintenance work was being undertaken.

General housekeeping within this area was of a high standard.
