Water Resources (Transitional Provisions) Regulations 2017

Notice is hereby given, in accordance with Paragraph 8 Part 2 of the Schedule to the Water Resources (Transitional Provisions) Regulations 2017 that the following applications have been made to Natural Resources Wales to licence previously exempt abstractions.

Application reference PAN-008545, submitted by Tenby Golf Club for a full licence to abstract water from underground strata at 18th Fairway, Tenby Golf Club, Tenby, Pembrokeshire at National Grid Reference SS 12583 99827. It is proposed to abstract water at the following rates and periods for use in irrigation: 10 cubic metres an hour, 70 cubic metres a day and 12,600 cubic metres a year, between 01 April and 30 September inclusive in each year.
